### The holder of this document

- has a knowledge of the care and handling of common domestic animals as well as applicable environmental and animal protection regulations
- has a knowledge of animal sicknesses, of preventative health and animal care and is able to handle and take care of sick animals
- has the ability to work with due care for and respect for nature and life, as well as taking account of environmental and ethical principles
- has the ability to use and maintain technical equipment in a safe way
- has a knowledge of how recycling thinking, economy in the use of energy and environmental factors can be applied in the care of animals
- has a knowledge of economics, running a business and entrepreneurship as preparation for being able to contribute to development and renewal in the vocational area
- has a knowledge of and experience of working environmental issues and the risks of accidents and can also work for a good physical and psycho-social environment
- is able to communicate in Swedish and English in accordance with needs in the profession, life in society and for further studies
- is able to use computers for work in the area

In addition, the holder of this document has knowledge at the upper secondary school level in Swedish, English, mathematics, arts, sports and health, science studies, religious studies and also civics.

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The programme provides basic knowledge for working with animal care e.g. in zoos, veterinary hospitals, zoological retailing as well as animal keepers in agriculture
