3. PROFILE OF SKILLS AND COMPETENCES

The programme aims at providing a basic knowledge of safety at sea and of the operation and maintenance of shipping vessels taking into account accessibility, safety of operations and quality. The programme also aims at providing the competence recommended in accordance with the convention (IMO/STCW Code 1995) on standards of training, certification and watch keeping for seafarers. The programme also aims at providing a foundation for future learning in working life and for further studies.

The holder of this document

- has a basic understanding of systems and knowledge of processes for work on shipping vessels
- has a knowledge of operations and maintenance of the mechanical equipment of shipping vessels, watch keeping in the engine room, alarm systems etc.
- is able to install, bring into operation and identify errors and also carry out operations and maintenance work
- is familiar with different energy systems and their environmental consequences, as well as which energy systems contribute to ecologically sustainable development
- has a knowledge of and is able to apply safety regulations applicable to employees on shipping vessels
- is able to work individually and as a member of a work team, and also critically examine and evaluate his/her own work
- is able to take into account economic conditions, environmental and safety standards, and health aspects at work, and is also familiar with how working environment issues are handled within the area
- has the ability to discuss and formulate views on ethical issues and views related to the profession
- is able to communicate in Swedish and English in their role as a motorman
- is familiar with the regulations and international agreements applicable to the area
- is able to use computers for communication and learning in the vocational area

In addition, the holder of this document has knowledge at the upper secondary school level in Swedish, English, mathematics, arts, sports and health, science studies, religious studies and also civics.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The programme provides a basic vocational knowledge and for working as a service technician in different areas of electronics. The programme provides to some extent preparation for other types of work in the operation and maintenance of energy technology systems.
