### The holder of this document has

- a basic knowledge of carrying out roofing based on descriptions and regulations when working with new buildings, conversions and extensions
- a knowledge of different types of materials and their importance for architecture and housing environments
- a basic knowledge of carrying out roofing based on existing rules for hot work
- knowledge of choosing materials based on use of resources and recycling
- a knowledge of how different occupations work together in the building process
- a knowledge of safety in hot work
- the ability to carry out work based on quality, the environment and safety factors
- the ability to use Swedish and English in a functional way in the profession
- the ability to use the computer as a tool in their professional work
- the ability to formulate, analyse and solve mathematical problems of importance in their role as a roofer
- the ability to work both independently and together with others
- the ability to adopt problem solving approaches

In addition, the holder of this document has knowledge at the upper secondary school level in Swedish, English, mathematics, arts, sports and health, science studies, religious studies and also civics.

The programme provides a basic knowledge of building construction with an orientation to working as a roofer.
